Section Two: Preparation for the Event

Pre-Race Setup

Pre-race drop-off, setup, and decoration must be completed prior to Friday or during hours when public gates are not open. Please contact your account executive to schedule a time when you may gain access to your suite.

Suite Check-In

All suite attendees must stop by one of the three suite check-in locations prior to entering the suites **daily**. At suite check-in, attendees will be required to sign a waiver (when applicable) and receive a wristband. Suite check-in opens at the same time as the gates.

Suite Check-In Locations

Suite check-in stations are located:

- In the Lot 5 Suite/VIP Parking Lot across Checkered Flag Blvd.
- Between Elevators 6 and 7 after entering through the gates.
- Between Elevators 2 and 3 after entering through the gates.

Neon Garage and Pit Area Dress Code

Las Vegas Motor Speedway and NASCAR will enforce the NASCAR dress code in the garage and cold pits, which now allows shorts, short sleeve and sleeveless shirts, as well as open-toed shoes. Smoking and alcohol are prohibited in the garages and on pit road at all times.

Pre-Race Pit Access

Your suite ticket and wristband will act as your pre-race pit pass and must be visible at all times. Guests must be 18 years old, or 16 if escorted by parent or guardian.

Security

You must pass through security checkpoints to access your suite. Therefore, you must have your gate/suite ticket and wristband with you and visibly displayed in order to pass through these checkpoints and while moving in and around the suites.

Please note any items left in the suites (banners, flags, programs, decorations, etc.) are the sole responsibility of the client. Las Vegas Motor Speedway is not responsible for any personal belongings left in your suite.

Entry and Re-Entry

You will have your ticket barcodes scanned upon entering, exiting, and re-entering through the grandstand gates and infield tunnel. Please have your tickets out and ready when preparing to enter or exit the gates or infield tunnel, and please arrive early to avoid any delays.

Section Four: Frequently Asked Questions

How do I receive my pit passes and Neon Garage passes?

Your gate/suite ticket and wristband will act as your pre-race pit pass. Each guest is required to stop by one of the three suite check-in locations prior to visiting your suite (See page 3).

Where is Lost and Found?

The Lost and Found booth is located at the end of the Neon Garage access tunnel under the grandstands. Contact the LVMS switchboard (702.644.4444) or receptionist on the ground floor of the Administration Building.

Where can I get a taxi or limo?

The limo station is located nearest Gate B, just off Checkered Flag Blvd. to the southwest of the Administration Building. To get a taxi, call 702.888.4888 or text 'taxi' or 'limo' to 702222.

Where can I receive medical attention?

LVMS Medical Centers are located inside the spectator gates under each terrace, identified by the medical Red Cross. In case of emergency ask your VIP services representative, uniformed police or security, or any LVMS staff member to alert emergency personnel via radio.

Where are ATMs?

ATMs are located near the first-aid stations, across from the Neon Garage entrance, inside the Administration Building lobby, outside the gift shop, at each end of the Petty Terrace, at each elevator in the Neon Garage, at the far end of the Earnhardt Terrace, and at each end of the main grandstands.

Are coolers or bottles permitted?

No. Coolers and food/beverage are not permitted to be brought into the superspeedway at any time.

Are pets permitted?

No. Animals, with the exception of service animals, are not permitted in the suites or superspeedway.

Where is the gift shop?

In addition to the many Fan Engagement Area vendors, a full range of motorsports apparel and gifts are available at Speedway World: the official gift shop of Las Vegas Motor Speedway. Speedway World is located in the bottom of the LVMS Administration Building near Gate C (marked Tickets/Gift Shop).

Can I go in the Neon Garage?

Yes, suite guests are permitted in the Neon Garage before, during, and after the race each day. Please note **each day's Victory Lane and Sunday's driver meeting will take place in the Neon Garage** and all suite guests are welcome to attend. Contact your account executive for additional information.

Can I go in the NASCAR garages?

No, a pre-race pit pass is included in the package, but not NASCAR garage access. However, we do have Lap Sponsorships available that do include a cold garage pass for Sunday. Contact your account executive for additional details.

What is the smoking policy on the suite level?

Smoking is **not** permitted inside any suite at LVMS. Guests wishing to smoke may do so outside of the suite on the suite-level walkway. Guests are reminded to utilize the ashtrays located outside of suite doors. Throwing cigarette butts over the suite-level railing will not be tolerated.

What is the smoking policy on the roof of the suite building?

Smoking is **not** permitted on the roof of the LVMS suite building. Guests in designated suites with roof access will be required to return to the suite-level walkway to smoke.

The following information will help you get in-and-out of Las Vegas Motor Speedway in the timeliest manner. In order to minimize traffic delays, please follow the traffic and parking procedures listed below. Your cooperation is greatly appreciated. Should you have any questions, please contact the LVMS Operations Department at 702.632.8234.

Suggested Route

Las Vegas Blvd. Northbound:



LVMS suggests you plan to arrive by using **Las Vegas Blvd.** Use any of the northbound lanes on Las Vegas Blvd. until you pass Range Rd. At this point, begin to merge over to the far-left northbound lane on Las Vegas Blvd.

Hollywood Blvd. Left turn:



As you approach LVMS on Las Vegas Blvd., merge into the far-left northbound lane and **turn left** at Hollywood Blvd.

Entry 11 Right turn:



Proceed on Hollywood Blvd. to **Entry 11**; this gate will be identified as the Lot 4 Premium Parking. Make sure your parking pass is clearly displayed and attached to your windshield.

If you plan to arrive via I-15 North, use this route

I-15, Exit 54:



Exit I-15 northbound at Exit 54 (Speedway Blvd.). Use the **right-hand shoulder lane** on the exit ramp.

Hollywood Blvd.:

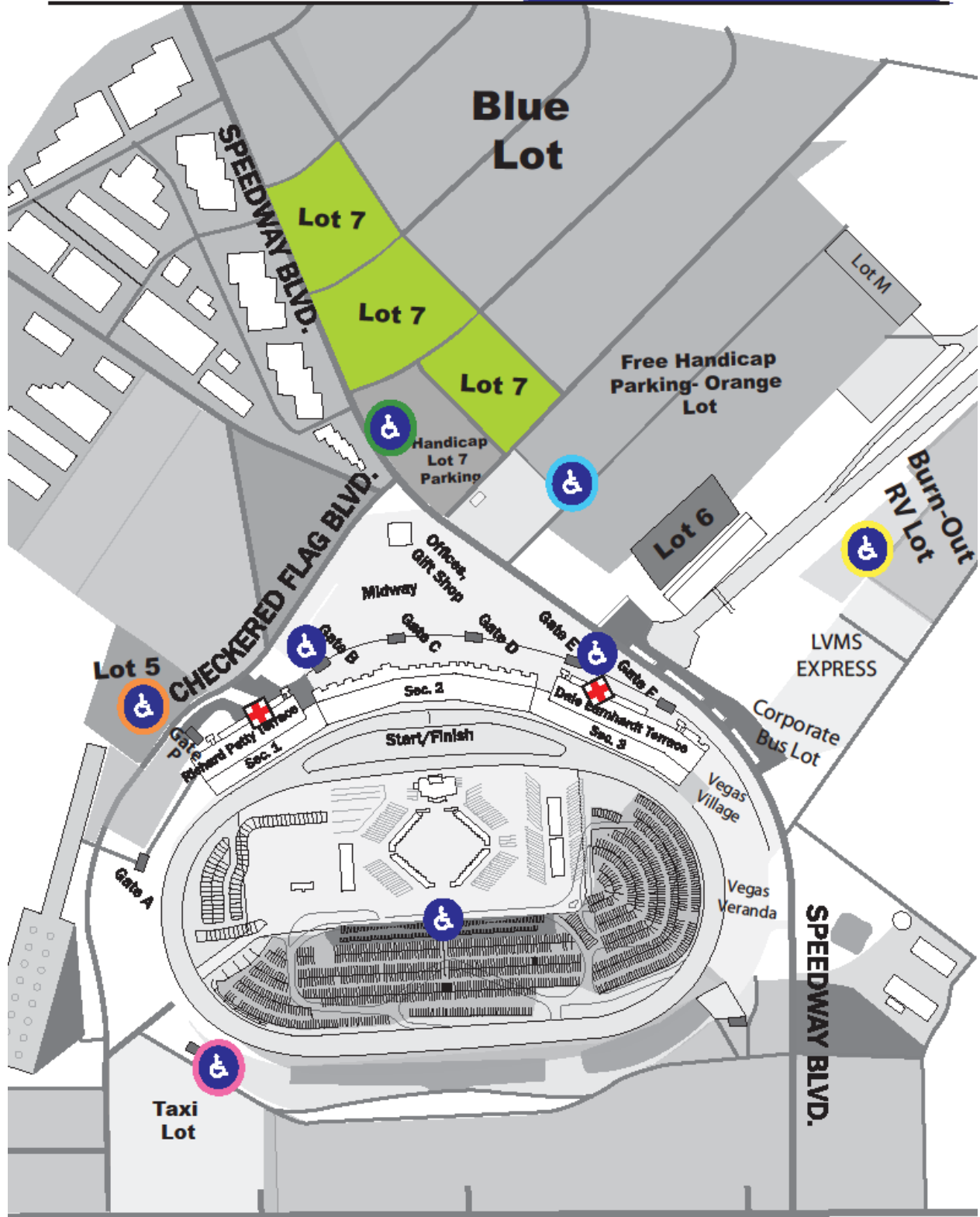


Make the first right-hand turn on Speedway Blvd. at Hollywood Blvd. (Next to the Petro Truck Stop)

Entry 11 Left turn:



Proceed on Hollywood Blvd. to **Entry 11**; this gate will be identified as the Lot 4 Premium Parking. Turn left at gate 11 and follow the direction signage to Lot 4 Premium Parking. Make sure your parking pass is clearly displayed and attached to your windshield.

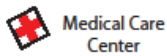

Disabled Parking Instructions

Entrance

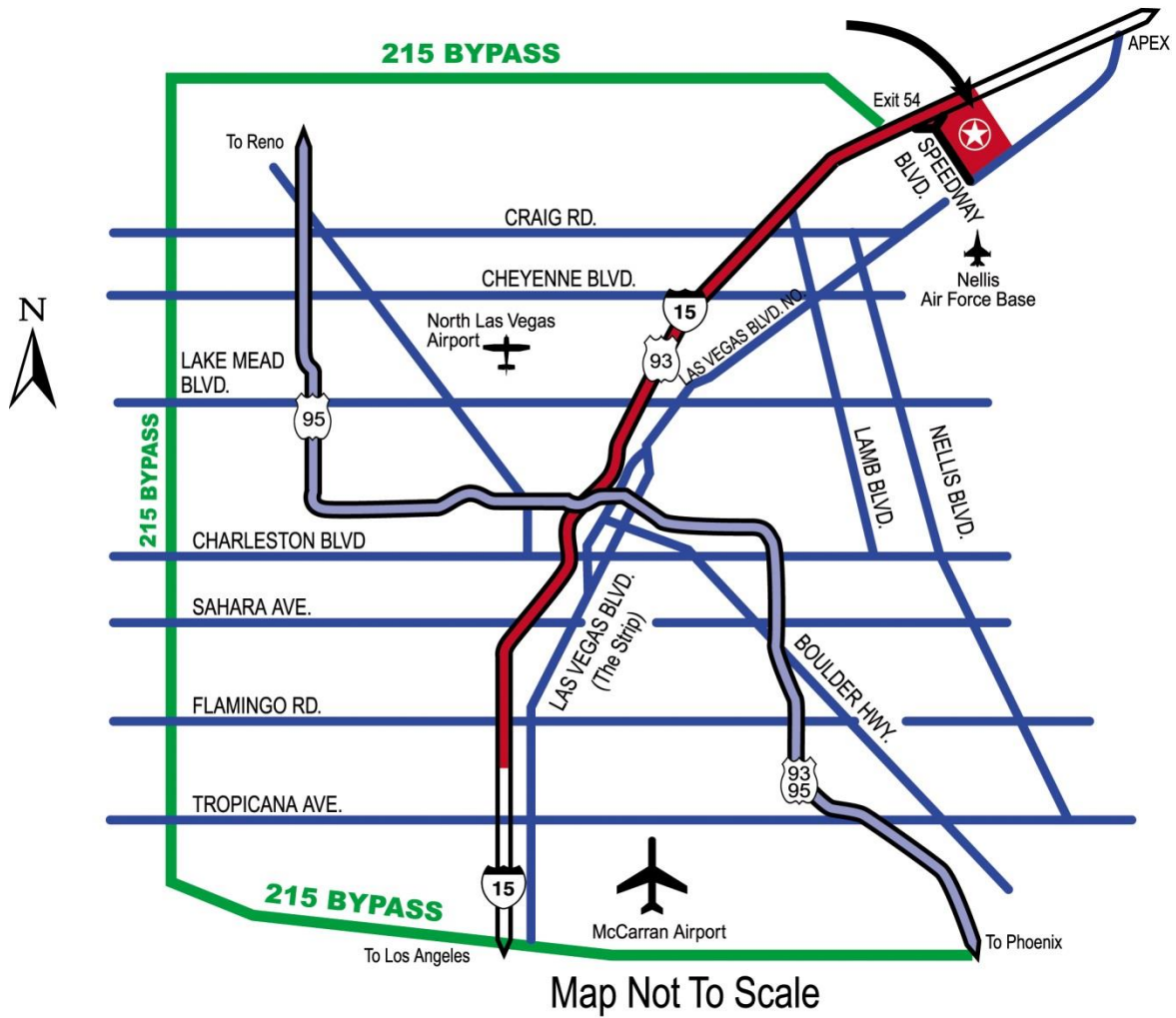
- Display **disabled persons placard** in lower driver's side corner of the front windshield
- Guests desiring to park in the handicapped lot **must arrive at the speedway via Interstate 15**
- From Las Vegas, follow **Interstate 15 North to Exit 54 (Speedway Blvd.)**
- **From Exit 54, proceed right and turn left adjacent to the LVMS marquee (crossing Speedway Blvd.)**
- Follow traffic officer direction toward the **Handicapped Parking Lot**
- Upon arrival, proceed through the **right gate into Handicapped Parking Lot**
- Failure to follow the above instructions will result in you being directed to the general parking lot

**It is important to understand the exit route will be different from the entrance route

Exit

- Follow signs and traffic officer direction to **Entry 8. Stay in left lane.**
- Exit Entry 8 by turning **left (North) onto Las Vegas Blvd.**
- **Proceed on Las Vegas Blvd. and follow signs to Interstate 15.**

Important – You **must** follow the designated transportation routes as they will be under the continuous watch of the Nevada Highway Patrol and the Las Vegas Metropolitan Police Department. These public safety officers will strictly enforce these routes. Your cooperation is appreciated.



Las Vegas Motor Speedway is located at Exit 54 (Speedway Blvd. / Hollywood Blvd.) off of Interstate-15, approximately 10 miles north of the world-famous Las Vegas Strip.
